A chapter should include at least five people with separate FHANA memberships who are eligible to vote in FHANA proceedings and who are full, voting members of the chapter. In the unfortunate event a Chapter official loses their Friesian horse during their tenure, they will be allowed to finish their term on the Chapter Board.
