- 1. **Opening Remarks & Announcement of Guests**. Mr. Laude called the meeting to order at 8:06 PM EDT.
- 2. **Approval of Previous Meeting Minutes**. Mr. Kelnhofer motioned to approve the October 2023 meeting minutes, and Mr. McGowan seconded the motion. The motion passed unanimously.
- 3. **FHANA Board Updates**. Ms. Miley reported that the Breeding Committee is working on establishing an annual Breeder of the Year award, an idea that the FMC brought forth. Board of Director nominations are open and will close on November 30th. There are three positions to be filled this year. The FHANA AGM will occur February 23 24 in Lexington, KY. The next edition of The Friesian magazine may be delayed due to Circuit 5. An update on Circuit 5 events was provided. Voting for the Lifetime Achievement award has been changed from chapter president voting to FHANA member voting.

- 4. The Role of the FMC w/in FHANA. A discussion about the FMC's role in FHANA took place. Ms. Osinga expressed concerns that the board has not taken some of the FMC's recommendations seriously enough. It was reiterated that the FMC has chosen not to be part of FHANA's formal structure and serves in an advisory capacity only to FHANA. Should the FMC wish to have a more formal role within FHANA or the ability to submit motions to the board, they will need to consider adopting a different relationship with FHANA in the future. If any member or chapter is displeased with the actions of the board or B Book II Committee or wishes to understand in more detail what actions are taking place with regard to B Book II, they should reach out to a FHANA board member to express their concerns or ask questions.
- 5. **Roundtable**. Ms. Jeffcoat expressed concern about comments made by Mr. McGowan on social media and asked for an apology. Mr. McGowan responded. Ms. DePuydt called a point of order regarding the discussion, citing mutual respect under the Democratic Rules of Order. Mr. Laude ruled Mr. McGowan's comments out of order. A brief discussion occurred regarding the FHANA Code of Conduct regarding social media use.
- Next Meeting Date. The next FMC meeting will occur on Wednesday, December 13th, 2023, at 8 PM EDT.
- 7. **Motion to Adjourn.** Mr. Kelnhofer motioned to adjourn the meeting, and Mr. McGowan seconded the motion. The meeting was adjourned at 8:44 PM EDT.
