

## Criteria for Dressage Video test scores acceptance for FHANA Predicate titles and end of year Dressage Awards

- A. All tests from Spotlight Horse Shows will be accepted.
- B. If an Online Video Dressage Site wishes to obtain FHANA acceptance of tests scored, the following application must be submitted, evaluated, and approved by the Sport Committee, approved by the FHANA Board of Directors, and approved by the KFPS:
- C. For a test that is not from a FHANA video approved site, the following application must be completed in its entirety and submitted to the Sport Committee for evaluation. If any criteria is not met, the score will not be acceptable for any FHANA award. If the Sport Committee does not approve a site, its request to be considered ends without having to go on to the Board

- 1. The URL of the organization's website
- 2. Proof that ridden, western, and driven dressage tests are offered.
- 3. Proof that only USEF/USDF, ADS, & WDAA level tests and KFPS Z tests are offered
- 4. Proof that all USEF/USDF, ADS, & WDAA level tests and KFPS Z tests are offered
- 5. Proof that all tests will be scored by a currently licensed judge:
  - a. For CE (Canada Equestrian) ridden dressage judges must be rated as Medium or Senior
  - b. For USEF/USDF ridden dressage the judge must have an "R" or "S" rating.
  - c. For CE, USEF, & ADS driven dressage judges must have an "R" rating
  - d. Any test scored by an FEI licensed judge will be acceptable.
- 5. If using an ADS driven dressage test, proof that the \$10 use fee will be paid to ADS
- 5. Assurance of the tests being videoed from C
- 6. After November 30 and before December 15 a FHANA reporting document must be submitted to the Sport Committee Chair that contains the show name, FHANA member names, FHANA membership numbers, horse names, horse KFPS registration numbers, test names, test scores, and links to the video tests.
- 7. By January 15 of the following year, a FHANA reporting document must be submitted to the Sport Committee Chair with the FHANA names and FHANA membership numbers of the end of year high point award recipients.
